

Call for Entries

Midland Artists Guild 32nd Annual Juried Art Exhibit 2016 March 4-31

ELIGIBILITY:

- Artist must be a member of the Midland Artists Guild. Membership dues must be paid prior to mailing this entry form. **Dues will not be accepted with the show entry form.** Check the MAG website to see if you are on the members list.
- All members must follow all entry procedures.

ENTRY PROCEDURE:

- A registration fee of twenty five dollars (**\$25**) will be charged each artist submitting art work. No Refunds.

Mail check or money order and completed entry form to: MAG Juried Exhibit, PO Box 1892, Midland, MI 48641-1892
Entry forms must be postmarked on or before the date of deadline: February 17, 2016.
Once submitted entry forms cannot be changed as printed materials will be completed before art is accepted.
- Entry is limited to three (**3**) works per artist.
Entry **must be original work** of artist completed in the past 3 years and not been exhibited in a prior MAG juried show.
Reproductions of original art are **NOT eligible**.
- 2-D **must be framed and wired for hanging** (no sawtooth hangers). Entries are restricted to a maximum size of four (4) feet in any direction. For safe handling, entries larger than 24x30 should be framed with plexi-glass - not glass .
3-D **must be completely assembled and ready for display**.
All 2D and 3D works are limited to a maximum weight of 40 lbs.
Entry tag must be completed and attached to back of 2-D or bottom of 3-D work.
- All art works **must be titled**. "Untitled" works will not be accepted.
- Work submitted is to be delivered to Grace A Dow Library mezzanine on **March 1 between 4:00 p.m. and 7:00 p.m.**
If you cannot bring your work, please have someone deliver it for you.

JUROR:

The Midland Artists Guild is pleased to have Alan Maciag as the juror for our exhibit. Alan is a 1974 graduate of Central Michigan University with a Masters Degree in Art Education. He is retired after teaching art for the last thirty-two years in the Frank-enmuth School District. An avid drawer, Alan has captured visual memories of past vacations throughout Michigan. These sketches have served as valuable subject matter for many of his oil paintings. As a plein-air painter, he captures the essence of the visual moments presented before him in his garden and the farmland around his home.

- **Declined Work:** You will receive a phone call for declined work pick up on March 2. All declined work must be removed from the exhibit area by Friday, March 4. If you cannot be there, designate someone to pick up your work.
- **Accepted work:** Must be picked up at the end of the exhibit on March 31 (do not remove work early). Any work remaining at the end of the day will be removed to clear the area for the library's use. Storage charges could be applied.

AWARDS:

- Awards will be presented at the opening reception on Saturday, March 5 between 6 & 8 pm and will include: \$200 Best of Show, \$150 Best 2-D, \$150 Best 3-D, \$100 Members Choice, several Sponsored Awards of Excellence, and several sponsored Awards of Merit. A People's Choice Award will be presented after the exhibit closes.
